



## Financial Audit for Three Years FY 2023 - 2025

**Background:** EcoPeace ME is a unique organization that brings together Jordanian, Palestinian, and Israeli environmentalists. Our primary objective is the promotion of cooperative efforts to protect our shared environmental heritage. In doing so, we seek to advance both sustainable regional development and the creation of necessary conditions for lasting peace in our region. EcoPeace has offices in Amman, Ramallah, and Tel-Aviv. This request for proposal is for the Israeli office only.

**Description of the mandate:** EcoPeace would like to contract an accounting firm to conduct a financial audit for three years beginning with fiscal year January 01, 2023, to December 31, 2023. EcoPeace expects the incumbent audit firm to obtain and present to the management a reasonable assurance about whether the financial statements are free from material misstatements and to express an opinion on whether those statements present fairly the financial performance and cash flow of the organization. Lastly, as part of the audit process, EcoPeace also expects the audit firm to examine the organization's internal controls over financial reporting.

**Expected Deliverables:** The service provider is expected to deliver the following:

1. Hebrew audit report in local currency.
2. English audit report in USD currency.
3. A Management Letter on the existing internal controls over the financial reporting involved in the preparation of the payments and cash receipts; as well as a highlight of any material or immaterial weaknesses in the internal control noted for each country and the recommendations to improve them.
4. Provide representation for EcoPeace before the tax authority and national insurance. This will include submitting Form 126 and Form 856 as well as Form 1215.
